

Waiver of Liability Relating to Coronavirus/COVID-19

Coronavirus/COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact, by contact with contaminated surfaces and objects and in the air. Certain persons infected by COVID-19 show no symptoms and can spread the disease. The exact methods of spread and contraction continue to be investigated; treatment continues to be developed; and there is no cure or vaccine for COVID-19. COVID-19 can cause serious and potentially life threatening illness and even death.

Nevada Ballet Theatre ("NBT") cannot prevent you (the "student") from becoming exposed to, contracting, or spreading COVID-19 while utilizing NBT's premises, dance lessons or other activities provided by NBT. It is not possible to prevent against the presence of the disease. Therefore, if the student chooses to utilize NBT's dance and other services and/or enter NBT's premises the student may be exposed to/or increase the student's risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself as the student in order to utilize NBT's dance lessons and other activities and premises in person.

WAIVER OF LAWSUIT/LIABILITY. I hereby, and if the student is a minor, on behalf of my minor child, forever release and waive my or the student's right to bring suit against NBT and its trustees, officers, managers, agents, employees or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing NBT's dance lessons and other services and premises. I understand that this waiver means I give up my right, including rights of the student, to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I or the student may have to seek damages, whether known or unknown, foreseen or unforeseen.

CHOICE OF LAW. I understand and agree that the law of the State of Nevada will apply to this contract.
